	Ms. Carter explained that was the final	
	year of the Papenfuse administration and	
	as such it is not reflective of the Williams	
	administration. She added that it was	
	pretty much the same as the results of	
	the 2020 audit with possibly one more	
	finding. She concluded by saying the City	
	is working to finalize the 2022 audit	
	report by the end of 2023.

	Ms. Carter reminded everyone that this year the ICA Board granted a permanent change to the submission date for the City's annual update to the Five-Year Financial Plan to August 31st of each year.	
	Ms. Carter reviewed the upcoming submission date and the review schedule for the Five-Year Financial Plan update scheduled to arrive within days after the meeting.	
	After the City submits the report, the ICA Board has thirty days to respond. If the ICA Board disapproves with suggestions, the City will have fifteen days to respond.	
	She concluded that September will be spent reading and reviewing. She added that the ICA will request a review from the City Controller's Office.	
	Audry reminded Ms. Kelley that with the submission, the ICA Board requires a letter from the Mayor as Chief Fiscal Officer attesting to the Plan.	
	Mr. Stonehill noted that the next meeting is September 27 th and the ICA response will need to be sent following that meeting.	
	Ms. Carter asked everyone to send their calendar availability to Mr. Stonehill.	
	Ms. Carter made some comments about fund balances and the DCED and Controller's reports.
